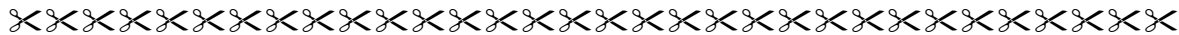
### **CALSS Registration deadline is January 22, 2012.**
